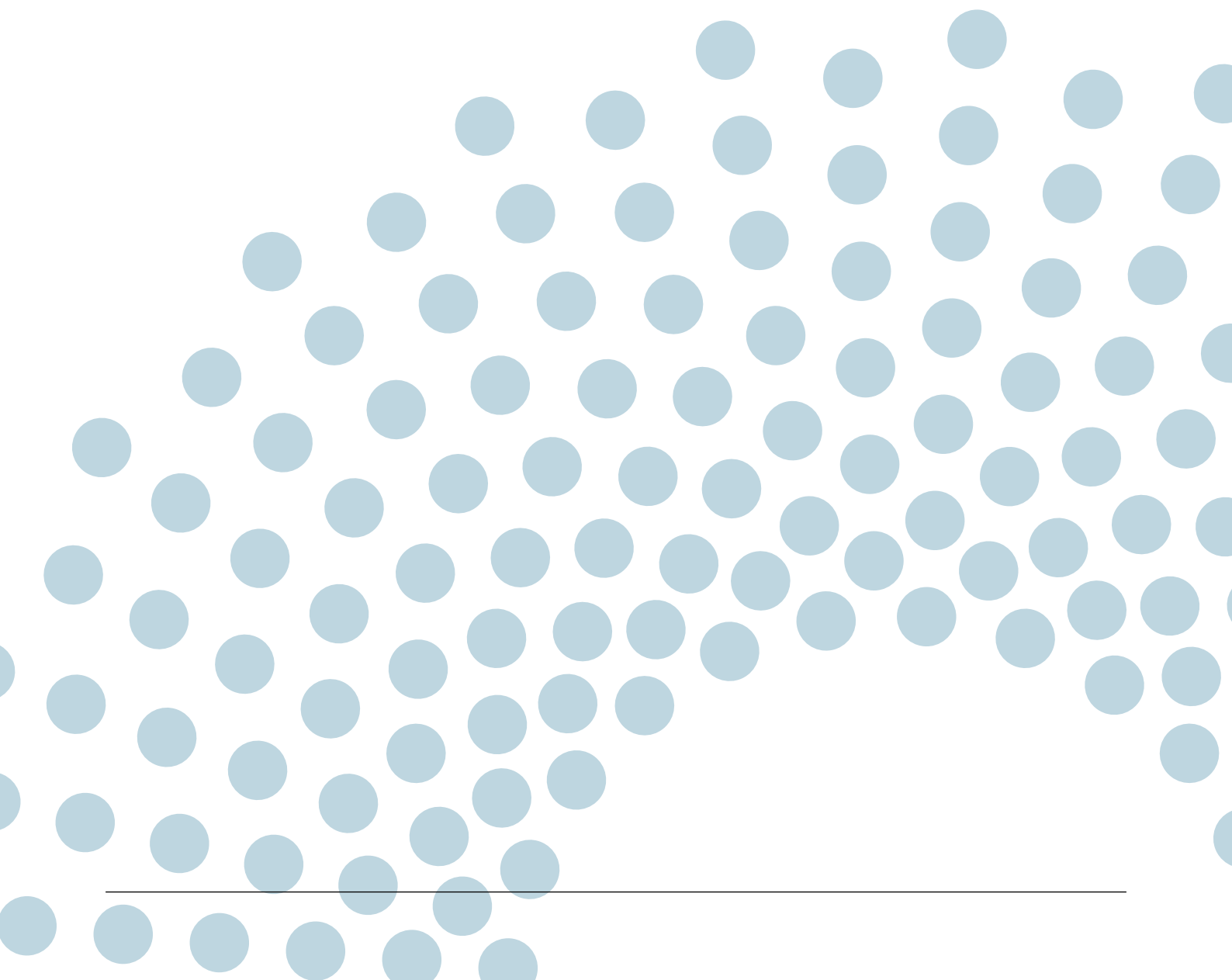

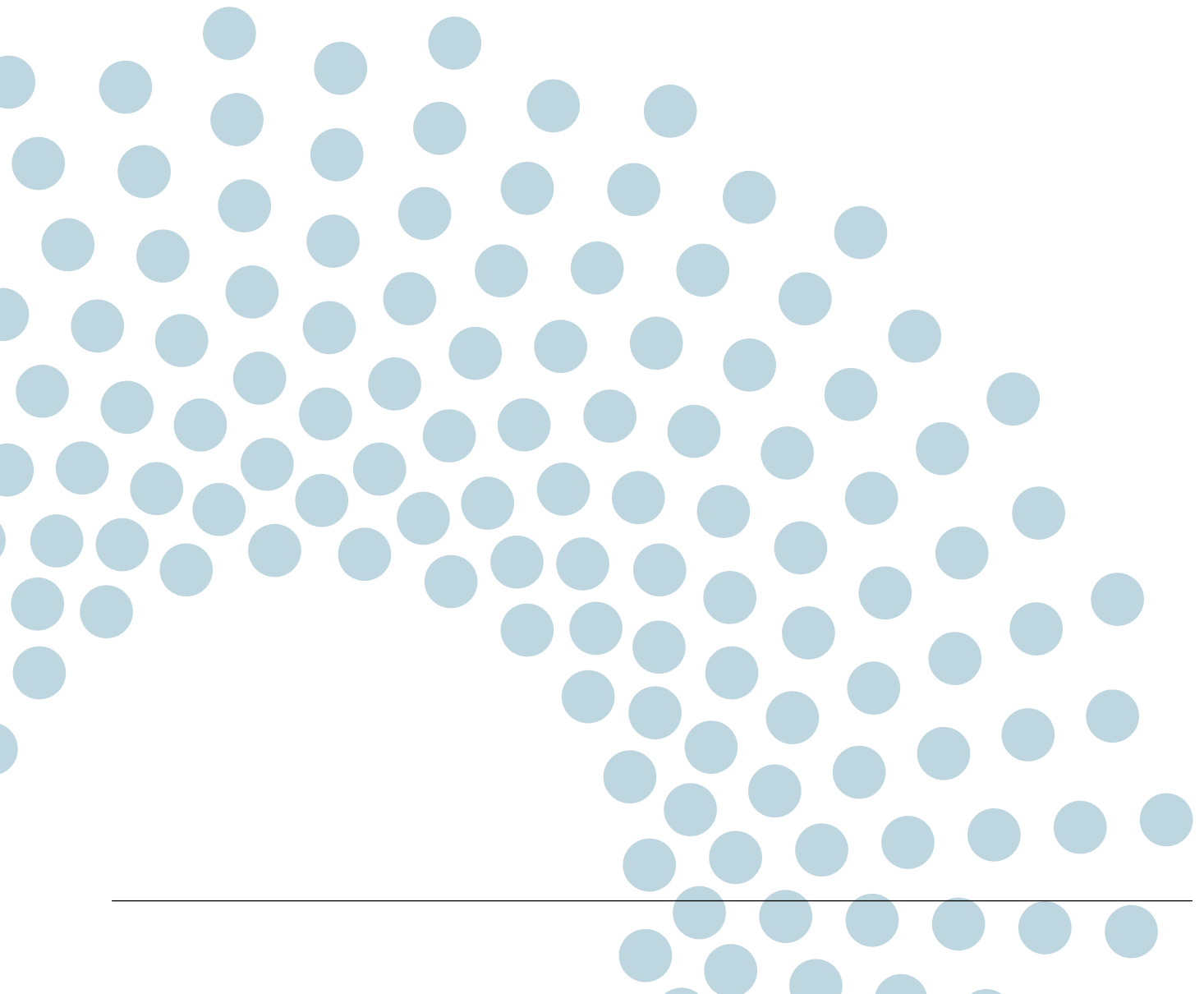

The ILA Annual Conference will be chaired by the Honourable Mr Justice Zacaroli. On the first day in a post-Brexit world, we will begin with a key note address on the impact of Brexit on the City and financial markets from a representative of the City of London Corporation, followed by a case study looking at the impact of Brexit on a German car manufacturer operating in England. A series of speakers will then cover various topics, including distressed retail cases, pensions, a U.S. perspective on the UK Government's proposed corporate insolvency reforms, the rise in administrator challenges and the future of cross-border restructurings (with views from Asia, the Cayman Islands, Ireland and the U.S.).
